On receipt of your application, your preferred date will be considered and you will receive written confirmation of your street stall dates. Please check the date, whilst every effort will be made to accommodate your request, stall dates will be allocated on a first in basis.

Please advise at your earliest convenience if you decide not to hold a street stall on a date that has been allocated to your organisation, to enable those on the waiting list to have an opportunity.

Please note that permission to hold a street stall is granted subject to the following conditions:

- Certificate of Currency of current Public Liability Insurance (*copy to be provided to Council with application*).
- All paper and rubbish from the street stall to be cleaned up by stall holders.
- Tables and all items relating to the street stall are located against the wall so as not to obstruct access to the public, and only set up in the alcove outside of IGA.
- Stall Holders are not to harass or intimidate pedestrians. Members of the Public will approach the Stall if they wish to and should not feel compelled.

Furthermore, Council requests that other organisations refrain from selling goods/raffle tickets when approved street stalls are operating (*as advertised in Council News, Grenfell Record and on Council's website: <https://www.weddin.nsw.gov.au/Community/Events>* ).
